# **Minutes of Last meeting**

Minutes from the last Parish Council meetings held on 3<sup>rd</sup> September 2015 were discussed and agreed to be a true record of proceedings.

Cllr D Appleby declared an interest in planning applications.

Maurice Buck Technical consultant from K and M Lighting was present to discuss LED lighting options. Mr. Buck showed the Council different lighting options and the Council decided to have one LED bulb fitted to a streetlight in Hilgay for the parishioners to see before any further decisions regarding changing the other Parish owned lights to LED is made. The light will be charged near the school on Church Road.

## Chairman's reports/updates

Cllr G Carter welcomed the new members of the Parish Council.

Cllr G Carter and Cllr A Hall (as Clerk to Hilgay Feoffee Charity) gave an update to the Council on issues regarding the slipway at Bridge Street. The issues have been related to who owns the freehold of the slipway and wharf. This has been an ongoing issue and the Parish Council and Feoffees had set aside some funds to cover the legal costs involved. The

Feoffee Trustees have now made the decision not to pursue the matter via a Land Registry tribunal as possible costs involved could reach £10,000. Cllr G Carter proposed the Parish Council write to the Land Registry to express Council concerns with the current registration of that area and will propose that together with The Feoffees, the Parish Council will negotiate with Mr. Collins a compromise to ensure the future use of the entrance and slipway.

The football hut is still in need of attention; Council will request that Mr. Dent provide a written report on repairs or action required within 28 days. Once a report has been received by the Council some support may be offered to Mr. Dent to help with the action required.

#### Maintenance reports/updates

The wooden arch entrance to Hilgay Play area has been removed as it was rotten. Fly tipping behind to youth shelter on the playing field Lots of dog fouling on land near cemetery Goal posts require painting

Rubber matting needs replacing under the roundabout; this will be done in spring.

Following a play area inspection report carried out by Wicksteed Leisure, the bench on the concrete where the old rocking horse was will be removed.

Under the old slide at Hilgay an impact surface is required; Quotes have been received for this to the value of £504.00. Clerk will investigate one other option before accepting this quote. If the second option is not viable then Council has authorized Clerk to accept quote of £504.00.

The rotating hand glider also requires some repairs; Cllr G Carter will inspect this.

#### Correspondence

Norfolk County Council has informed the Council that they have decided to undertake a rent review of your holding. The proposed new terms will be determined next year to take effect from Michaelmas 2016. The new rent will be payable from Lady Day 2017.

A letter has been received from a parishioner who would like to place a memorial bench under the beech tree opposite the playing field. Parish Council has no objections to this. However, Clerk will advise parishioner that this is BCKLWN land and their permission will be required before a bench is positioned on the land.

Also another request was made from a parishioner who would like to place a memorial bench at the cemetery near the grave of Mr. Loveridge, Council have agreed to this.

Mr. Deptford has sent information regarding infant/child kits for use with the defibrillator. The cost of the kit is £115.00 + vat. Council suggested some fundraising for this. Cllr G Carter will discuss with the village hall committee.

Cllr Bates informed the Council that the allotment shed had been broken into on the 11.11.15, the police are involved. Some allotment holders have fires on the land; the tenant agreement will be reviewed regarding this issue.

The cremation area needs to be extended; Council agreed that the cremation stones will be set flush in the grass and positioned 18" apart.
