#### Chairman's reports/updates

One streetlight near the school was changed to an LED bulb; Councils will discuss changing all lights to LED at a later date.

The football hut is still in need of attention; Mr. Dent now has access to the hut and will investigate ASAP.

As discussed at the last Parish Council meeting, Cllr A Hall acting as clerk to FEOFFEE's held a meeting on 08.12.15 with Mr. Collins to discuss and agree the boundaries for land registration. A plan has now been submitted to the Land Registry by the Solicitor.

#### Maintenance reports/updates

C Wills has requested a leaf blower for use in the cemetery; quotes will be reviewed next meeting.

Two new dog bins have arrived and will be erected on Church Road and near the junction of Hubbard's Drove and Wood Hall Road.

The rotating hand glider requires some repairs; Cllr G Carter and C Wills did inspect the equipment and a quote has been received from Wickstead to carry out the repairs. The total cost will be £776.72 plus VAT.

Hedge around the playing field (church side) is becoming too high; C Wills suggested this be cut to a more reasonable height. Cllr Bates requested that quotes be obtained to trim the entire hedge along the Church Avenue both sides.

## **Matters requiring attention**

Clerk will investigate grants/funding for proposed plant troughs and tree planting in the village.

There is a piece of Common Land on Sandy Lane which was not registered in the past by the Parish Council; it has since been included in the registration of the Woodhall estate. Cllr V Martin has undertaken to investigate the ownership and registration of the piece of land in question and will report next meeting.

The Parish Council reviewed 2014/15 expenditure and agreed to apply a 3% increase onto the precept for 2016/17.

There was a proposal not to increase, to which 4 Councilors agreed.

Proposal to increase by 3% to which 4 Councilors agreed.

Therefore the Chair held the casting vote and a 3% increase will be applied.

Proposer: Cllr R Houghton

2nd: Cllr P Carter.

FEOFFEE has decided to remove the willow trees on the River filed as they are becoming dangerous, they have requested a contribution from the Parish Council of 50% of the costs. The maximum cost should be no more than £1000 in total.

Proposer: Cllr J Evans

2<sup>nd</sup>: Cllr G Harris.

It was agreed to pay 50% and it was strongly suggested that the trees be replaced with another suitable tree.

There are a number of hedges alongside the highways which require trimming in Ten Mile Bank and Hilgay, Clerk will report to Highways department.

Cllrs have raised concerns with road safety along the A10; the improvements to the road at the junction of the farm shop have not yet been completed. Clerk will contact highways to discuss this and the renewal of the bridle path signs and possibility of a speed reduction in that area.

The drains near the school in Hilgay are blocked, there is a large puddle of water in this area, and it has been reported to highways a number of times.

Cllrs have reported youngsters are using motorbikes on the public rights of way, they have also been reported as being abusive to people and intimidating, this will be reported to the police.

Reports of speeding on Tower Road and Ely Road. Volunteers are still required for the Community Speed Watch scheme, please contact Clerk for details.
